In 2020, The Eureka County Sheriff's Office handled 17,726 Calls for Service, compared to the 15,026 Calls for Service in 2019.

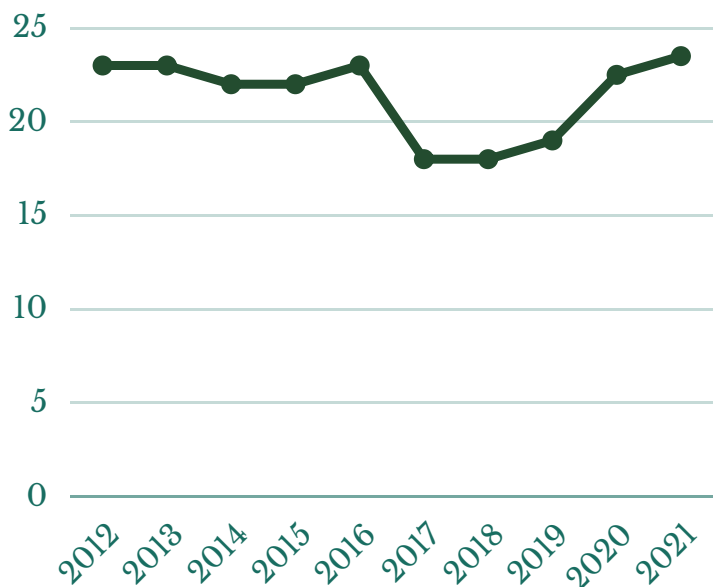
In Q1, The Eureka County Sheriff's Office handled more calls then 2012, with less staffing then we had in 2012.
