## YOUTH TEAM BRANDING CONTEST

August 8<sup>th</sup>, 2025 Start time: 10:00 AM

## **Competition**

- ➤ Timed basis 12-minute time limit
- The four fastest times will be placed 1<sup>st</sup>, 2<sup>nd</sup>, 3<sup>rd</sup>, and 4<sup>th</sup>.

# **Branding Rules**

- > Youth may only enter once.
- All entries must be pre-paid and received by August 4<sup>th</sup>, 2024.
- Entry Fee: \$25 per team
- All members of the team must sign Branding Contest Entry Form and agree to the Express Release and Assumption of Risk on the entry form.
- ➤ All participants must be in Western Attire Long sleeve shirt, hat, etc.

#### **Ground Rules**

- Each team will head and heel two head of cattle.
- Ground crew is allowed to help hold ropes if needed for safety purposes.
- Legal head catches:
  - o Around horns (no figure-eights allowed)
  - Around head
  - o Head and front leg (figure-eight allowed)
  - Half head
- > Illegal head catches can be removed and the animal can be re-caught.
- All four feet must be stretched with ropes before paint is applied.
- > Dropped head rope can be picked up without penalty if the ground crew is back in the circle before the animal is heeled.
- Dropped head rope after animal is heeled can be picked up without returning to the circle.
- After an animal is branded, it must be on all four feet before the next animal is caught. If the animal is up on all 4 legs, then lays down, the next animal can be roped.
- On the last animal, the animal must be on all four feet, free of ropes, iron back in the fire, ground crew in the circle, then the judge will signify final time.
- No person but the team and judges are allowed in the pens.
- Once the contest has started, there will be no discussion with the judge.
- > If a fence goes down or time stopped at any pen, all three watches are stopped. Time will be recorded, and all three watches cleared and restarted. That time will be added to the first time.
- The Eureka County Fair Board will supply branding iron (paint).
- > Complaints, concerns, or discrepancies must be presented to a Fair Board member for review.

## **Penalties**

- A penalty of 20 seconds will be applied for not walking to the edge of the herd for each calf.
- > A 30 second penalty per incident will be applied if the ground crew leaves the circle before the animal is headed and heeled (judge's discretion).
- A 30 second penalty per incident will be assessed if a horse is ridden through the circle.
- ➤ A 30 second penalty for each heavy or improperly placed marking.
- A 30 second penalty for each light mark.
- A 30 second penalty if chalk is dropped or placed on the ground outside of the circle.
- A 30 second penalty if a new animal is roped if the previous animal is not on all four feet.
- > A 90 second penalty for undue roughness; a second incident of roughing cattle will disqualify the team. This includes running cattle into the fence.
- Failure to properly rectify or remedy an illegal catch will result in disqualification.
- Animal marked on the wrong side will result in disqualification.
- Ground crew is allowed to carry chalk stick at all times.

### **Final Decision**

- In the event of a discrepancy of penalties or disqualification between times and judges- the decision will be reviewed between timers and judges and the judge will have the final say.
- The Eureka County Fair Board Committee shall have the overall final decision on any disputes about entering, penalties, procedure, and events.
- > Disputes, harassment, intimidation, or threats towards the judges, timers, or any volunteers will result in immediate disqualification.
