

OFFICER INVOLVED SHOOTING

ON WEDNESDAY, JUNE 16TH, 2021 AT APPROXIMATELY 0958 HOURS, THE EUREKA COUNTY COMMUNICATION CENTER RECEIVED A CALL FROM NEVADA HIGHWAY PATROL, REPORTING A SHOOTING THAT HAD JUST OCCURRED ON SR-278 NEAR MILE MARKER 68.

AN NEVADA DEPARTMENT OF TRANSPORTATION WORKER HAD BEEN SHOT IN THE ACTIVE CONSTRUCTION ZONE.

UNDERSHERIFF TYLER THOMAS, NHP TROOPER ERIC CANDEE AND SHERIFF JESSE WATTS PROCEEDED TO THE LAST KNOWN LOCATION OF THE SUSPECT.

AT APPROXIMATELY MILE MARKER 35, US THOMAS AND TROOPER CANDEE LOCATED THE SUSPECT, AND BEGAN A PURSUIT.

SHERIFF WATTS SUCCESSFULLY DEPLOYED SPIKE STRIPS AT MILE MARKER 27. THE SUSPECT PULLED OFF THE ROADWAY AND CRASHED AT MILE MARKER 26.

THE SUSPECT OPENED FIRE ON US THOMAS, TROOPER CANDEE AND SHERIFF WATTS.

AFTER OVER A MINUTE OF GUNFIRE, UNDERSHERIFF THOMAS FIRED TWO FINAL SHOTS, STRIKING THE SUSPECT ONCE AND ENDING THE EXCHANGE OF GUNFIRE.

THE SUSPECT WAS STRUCK AND KILLED AS A RESULT OF THE OIS.

NEVADA DIVISION OF INVESTIGATIONS IS COMPLETING THE OFFICER INVOLVED SHOOTING INVESTIGATION.

ELKO COUNTY SHERIFF'S OFFICE IS COMPLETING THE INTERNAL INVESTIGATION TO REMAIN TRANSPARENT AND UNBIASED.
