ADVERTISEMENT FOR BIDS

Sealed Bids for the Test Borehole Drilling for Groundwater Exploration will be received by Eureka County Public Works until **11:00 AM local time on September 16, 2025**, at the Eureka County Courthouse located at 10 South Main Street in Eureka, Nevada, at which time the Bids received will be publicly opened and read at 11:05 AM local time. The Eureka County Commissioners will consider awarding the contract on September 16, 2025, during the Eureka County Board meeting.

The project is located in the Kobeh Valley area within Eureka County, NV. The primary scope of work will encompass the drilling of up to three (3) groundwater exploration test holes, each test hole will be up to a total depth of 1,200 feet. The test holes will be drilled using the dual tube reverse circulation drilling method with a borehole diameter between 4-inch to 5-1/4-inches. Data collected from the boreholes will include logging of lithologic samples, collecting groundwater data (flow rates, temperature, TDS, pH, etc.), and water samples. The test holes will be abandoned in accordance with the Nevada State Regulations.

The Work will be substantially completed on or before October 31st, and completed and ready for final payment in accordance with the Contract Documents on or before November 15, 2025.

The engineer's opinion of probable cost estimate for the Project is \$225,000. The sole funding source for this project is from the Nevada Water Conservation and Infrastructure Initiative (NWCII). NWCII is encompassed within the State and Local Fiscal Recovery Fund (SLFRF). All sub-recipients and contractors are required to comply with SLFRF rules and guidance. Specific requirements of SLFRF are outlined in the Supplementary Conditions document.

Bids will be received for a single prime Contract. Bids shall be on a lump sum and unit price basis as indicated in the Bid Item Schedule Form.

Bid security shall be furnished in accordance with the Instructions to Bidders.

This proposal to the Owner is irrevocable for a period of **60 days** after the date of the bid opening. The Owner reserves the right to reject any and all bids. The Owner reserves the right to waive informalities, non-conformities, and irregularities. Omission or improper completion of any or all the required bidding documents may be considered as a reason for rejection of the Bid.

The Contractor will be required to comply with the labor and wage requirements in accordance with the provisions of the Northern Nevada Prevailing Wages (NRS 338) and Related Acts.
